If Bay A is in use: <ol style="list-style-type: none"> i. Access is via the RHS gate on the range ii. The shutter between Bay A & B is to be lowered iii. Heritage pistol is not permitted b. If Bay A is not in use access can be via the club room c. If Civil police are using Bay B, Bay C cannot be used 3. Range infrastructure is not to be used as targetry or to zero/check firearms 4. A Suitably Qualified Experienced Person (SQEP) is to be appointed as the responsible RO when shooting on Bay B. 5. Alcohol is not permitted in the Club Room

Permission to fire from any other position, or use a muzzle brake, must be notified in the booking request and granted by the Range Office in order to allow suitable target allocation on the range</p> <p>8. Changes of position are permitted within any detail or practice outside competition providing all firers follow the same sequence, and in competition in accordance with the conditions</p> <p>9. Fire and movement is not permitted on Cheylesmore Range</p>
<p>Targetry</p>	<p>10. MAX TCH: 1.5m</p> <p>11. Unless prior permission has been obtained from the CE only targets from the NRA approved set may be used</p> <p>12. Targets are to be used in the frames or holders provided and are to be engaged only from the recognised firing points and /or appropriate shooting station or peg. Any deviation from this is to be notified, in writing, and approved by the Range Services Manager.</p> <p>13. Skittles, falling plates or other hard targets may not be engaged within Cheylesmore Range</p> <p>14. Clay pigeons are not to be engaged within Cheylesmore Range</p>
